# CALL TO ORDER

## PUBLIC COMMENT

Kathleen Anderson Reinhold, 106 East Harriet Street, stated her concerns about traffic on Harriet Street that enter in and exit Jimbooo's Restaurant. Also, why the Village blocked off the entire street on this side of the tracks on Juliette which inconveniences the residents. She commented the no-horn area for the trains should be enforced better; and the guardrail behind Jimbooo's has become a parking lot making it difficult for area residents to back out of their driveways. She requested that practice be stopped.

Ms. Reinhold continued that older houses in Thornton, such as the one owned by the Pisarzewski's, should be fixed up. There is federal aid available for the upkeep of such homes. Additionally, she is concerned with the removal of trees in the parkways throughout the Village. Why is this being done? Lastly, she suggested the Village put together a festival to raise money.
